

**AN AGREEMENT** made on the 26<sup>th</sup> day of March 2013 between

- A. **AVANTI MINISTRIES LIMITED**, a Company registered in England and Wales, number 4906465, and registered as a charity with the Charity Commissioners number 1104111, with an office at 6 Clarence Road, Southend-On-Sea, Essex SS1 1AN ("the Ministry"), of the one part and
- B. **A PANEL** consisting of **JOHN LANGLOIS, ROBERT AMESS, and KEITH CIVVAL**, all care of the Evangelical Alliance, 176 Copenhagen Street, London, N1 0ST ("the Panel") of the other part.

#### **BACKGROUND**

- (1) The Ministry has become aware of certain allegations being made against Tony Anthony by third parties;
- (2) The Ministry is desirous of the allegations being investigated by the Panel as independent third parties nominated by the Evangelical Alliance.

#### **THE TASK**

1. The Ministry hereby appoints the Panel to investigate in a confidential manner all principal allegations against Tony Anthony and to report back to it in writing within three months, with a copy to the General Director of the Evangelical Alliance for submission to its Membership Committee ("the Committee").
2. The Report shall contain:
  - (a) a record of the witnesses who have been interviewed by the Panel and of the evidence that they adduced,
  - (b) a record of all documentary evidence provided to the Panel,
  - (c) the Panel's conclusions,
  - (d) the Panel's recommendations to the Trustees and
  - (e) a separate diplomatically discreet executive summary of the Panel's findings which shall be suitable and appropriate to be made available to a wider audience by agreement between the Ministry and the Committee.
3. If for any reason any publicity or questions arise as a result of this enquiry or otherwise it will be for the Ministry to respond to them, not the Panel.
4. The Panel shall undertake their duties in a professional manner and in a spirit of Christian conciliation as set out in Scripture, their prime goal being the glory of God, the honour of His Name and the healing of any divisions in the Body of Christ.
5. The implementation of any remedial action required as a result of the Report shall be the responsibility of the Ministry in consultation with the Committee.


6. This agreement may be signed in counterpart, whereby each copy signed by a signatory shall constitute a composite part of the single agreement.
7. The date to be entered on the first line of this Agreement shall be the date when John Langlois, as chairman of the Panel, shall receive a copy of this agreement signed by the Company Secretary of the Ministry.
